1. **Signetique I.T Pte Ltd Services.** Signetique Pte Ltd agrees to provide reseller with services described in the Description of Services for the purpose of reselling.
2. **Signetique I.T Pte Ltd Policies.** Reseller agrees to abide by Signetique I.T Pte Ltd Agreement. With reasonable prior notice to Reseller, Signetique I.T Pte Ltd reserves the right to change the Policies from time-to-time, in order to accommodate the needs of its customers, changing laws, and advancing technology. Signetique I.T Pte Ltd will inform the reseller at least 30 days prior to any pricing changes.
3. **Client Servicing.** The customers of the reseller are the sole responsibility of the reseller. The reseller is responsible for the actions of its customers. Signetique I.T Pte Ltd will provide the reseller any necessary technical support, however, the reseller is responsible for all administrative, support and billing, and any possible legal issues of their customers.

4. **Term.** The initial term of this Agreement shall be for 1 month. This Agreement shall automatically renew for a similar term thereafter, until terminated by either party with 30 days prior notice.
5. **Termination for Cause.** Reseller and Signetique I.T Pte Ltd shall each have the right to terminate this Agreement in the event of any material breach of this Agreement, or breach of Signetique I.T Pte Ltd Policies. Prior notice and right to cure may or may not be given, depending on the severity of the violation. For example, if Reseller violates a law, no prior notice or right to cure will be required.
6. **Signetique I.T Pte Ltd warranties.** Signetique I.T Pte Ltd represents that it will provide the quality and quantity of services specified in the Description of Services.
7. **Disclaimer of Warranties.** EXCEPT AS SET FORTH HEREIN, Signetique I.T Pte Ltd AND RESELLER EACH EXPRESSLY DISCLAIMS ALL REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
8. **Indemnification.** Reseller and Signetique I.T Pte Ltd each agree to indemnify, defend and hold harmless the other from and against any third party claim, action, suit, or proceeding arising out of the inaccuracy of any respective representation stated in paragraphs 8 and 9 above. Such indemnity shall apply to all losses, damages, liabilities, and reasonable attorney's fees and costs incurred by the party receiving the benefit of this paragraph.
9. **Miscellaneous Provisions.**
  - a) This Agreement will be governed by Singapore law without giving effect to principles of conflict of laws. Both parties agree to submit to jurisdiction in Singapore, and that any action brought regarding the enforcement or interpretation of this Agreement shall be filed in Singapore. The prevailing party in any action will be entitled to reasonable attorney's fees and costs.
  - b) If any provision of this Agreement is held to be unenforceable for any reason, the remaining provisions shall remain in full force and effect.
  - c) The waiver of any breach of this Agreement will not operate as a waiver of any other or subsequent breach.
  - d) This Agreement may only be amended in writing acknowledged by both parties.
  - e) The parties to this Agreement are independent contractors, and no agency, partnership, joint venture, or employer-employee relationship is intended or created. Neither party shall have the power to obligate or bind the other.
  - f) Any notices required or permitted hereunder may be given by electronic mail or fax if receipt is confirmed by the recipient, or if the notice is also sent by first class mail. Notice will be deemed given on the date the electronic mail is sent.

Signetique I.T Pte Ltd reserves the right to reject this Agreement by notifying Reseller by email within 96 hours of receipt of this Agreement.
